Substitute House Bill No. 6241

*House of Representatives, April 10, 2025*

The Committee on Environment reported through REP. PARKER of the 101st Dist., Chairperson of the Committee on the part of the House, that the substitute bill ought to pass.

## ***AN ACT CONCERNING AGRITOURISM.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1       Section 1. (NEW) (*Effective October 1, 2025*) (a) For purposes of this  
2       section:

3       (1) "Agriculture" has the same meaning as provided in section 1-1 of  
4       the general statutes;

5       (2) "Agritourism" means any agriculture-related educational,  
6       entertainment, historical, cultural or recreational activity, including, but  
7       not limited to, you-pick operations, corn mazes, hay rides or farm  
8       markets that are conducted on a farm which allows or invites members  
9       of the general public to observe or participate in such activity;

10       (3) "Agritourism provider" means any person who owns, operates,  
11       provides or sponsors an agritourism activity or an employee of such a  
12       person who engages in or provides agritourism activities, whether or  
13       not for a fee;

14       (4) "Farm" means land that is composed of tracts, lots or parcels that  
15 are devoted to agriculture;

16       (5) "Participant" means any individual, other than the agritourism  
17 provider providing such activity, who observes or participates in an  
18 agritourism activity; and

19       (6) "Risk inherent in an agritourism activity" means any danger or  
20 condition that is an integral part of an agritourism activity, including  
21 each of the following:

22       (A) The surface and subsurface conditions of land;

23       (B) The behavior or actions of wild animals not kept by or under the  
24 control of an agritourism provider;

25       (C) The behavior or actions of livestock or domestic animals, other  
26 than damage by dogs, as described in section 22-357 of the general  
27 statutes;

28       (D) The ordinary dangers associated with land, structures, animals or  
29 equipment ordinarily used in agriculture or agritourism activities;

30       (E) The possibility of personal injury, property damage or contracting  
31 illness from proximity to, or physical contact with structures,  
32 equipment, animals, animal feed, farm chemicals or animal waste; or

33       (F) The possibility that a participant may act in a negligent manner,  
34 including by failing to follow instructions given by the agritourism  
35 provider or by failing to exercise reasonable care while engaging in the  
36 agritourism activity that may contribute to personal injury or property  
37 damage to such participant or another participant.

38       (b) In any civil action, an agritourism provider shall be immune from  
39 liability for any personal injury or property damage a participant  
40 sustains during an agritourism activity if the participant incurs personal  
41 injury or property damage as a result of a risk inherent in an agritourism  
42 activity.

43 (c) An agritourism provider shall not be immune from civil liability  
44 for harm sustained by a participant if any of the following applies:

45 (1) The agritourism provider acts negligently or with a wilful or  
46 wanton disregard for the safety of the participant;

47 (2) The agritourism provider purposefully causes personal injury or  
48 property damage to the participant; or

49 (3) The agritourism provider's actions or inactions constitute criminal  
50 conduct and cause personal injury or property damage to the  
51 participant.

This act shall take effect as follows and shall amend the following sections:

The bill has no fiscal impact by granting immunity from civil liability to certain agritourism businesses. The court system disposes of over 250,000 cases annually and the number of cases potentially impacted is not anticipated to be great enough to result in savings.

**OLR Bill Analysis****sHB 6241*****AN ACT CONCERNING AGRITOURISM.*****SUMMARY**

This bill grants immunity from civil liability to agritourism businesses that offer the general public the opportunity to observe or participate in agriculture-related activities on a farm (e.g., you-pick operations, corn mazes, hay rides, farm markets), whether or not for a fee. Under the bill, an agritourism provider (i.e. an agritourism activity's owner, operator, or sponsor and their employee) is not civilly liable for a participant's property damage or personal injury resulting from an agritourism activity's inherent risks (see below).

The bill provides limitations on the immunity granted. Specifically, an agritourism provider will be liable for harm to a participant if the provider (1) acts negligently or with willful or wanton disregard for the participant's safety, (2) purposely causes a participant's personal injury or property damage, or (3) commits criminal conduct that causes a participant's personal injury or property damage.

EFFECTIVE DATE: October 1, 2025

**INHERENT RISKS**

Under the bill, a "risk inherent in an agritourism activity" is any danger or condition that is an integral part of the activity, including the following:

1. the land's surface and subsurface conditions;
2. the behavior or actions of wild animals that the agritourism provider does not keep or control;
3. the behavior or actions of livestock or domestic animals (other

than damage by a dog when the dog is not provoked);

4. ordinary dangers associated with land, structures, animals, or equipment typically used in agriculture or agritourism activities;
5. the possibility of sustaining injury, property damage, or illness from being near to or having contact with structures, equipment, animals, animal feed, farm chemicals, or animal waste; and
6. the possibility that an activity participant may act negligently, including by not (a) following the agritourism provider's instructions or (b) exercising reasonable care during the activity.
