AN ACT CONCERNING A REDUCTION OF SINGLE-USE PLASTICS AND POLYSTYRENE WASTE.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 That the general statutes be amended to: (1) Prohibit any state or
- municipal government agency, including any vendor with a
- 3 government contract, schools and any business, including food vendors,
- from selling, using, purchasing or providing: (A) Any food ware or 4

- beverage product composed in whole, or in part, of polystyrene, such as
- 6 takeout containers or trays; (B) any packaging product composed of
- 7 polystyrene, including packaging peanuts; and (C) any single-use
- 8 plastic cutlery, straw, plastic stirrer, splash stick or food ware accessory
- 9 to a customer, except a single-use plastic straw may be provided to
- 10 persons with a disability; (2) require state buildings, municipal
- buildings and schools that are required to contain drinking fountains to
- 12 also have an equivalent number of bottle-filling stations; (3) require a
- 13 report on establishing a requirement to reduce single-use plastic
- 14 packaging and food service products by not less than twenty-five per
- 15 cent by 2032.
