728 shall remain in effect until June 30, 2012, except any facility that would
729 have been issued a lower rate for the fiscal year ending June 30, 2012,
730 due to interim rate status or agreement with the department, shall be
731 issued such lower rate. For the fiscal years ending June 30, 2014, and
732 June 30, 2015, rates shall not exceed those in effect for the period ending
733 June 30, 2013, except the rate paid to a facility may be higher than the
734 rate paid to the facility for the period ending June 30, 2013, if a capital
735 improvement approved by the Department of Developmental Services,
736 in consultation with the Department of Social Services, for the health or
737 safety of the residents was made to the facility during the fiscal year
738 ending June 30, 2014, or June 30, 2015, to the extent such rate increases
739 are within available appropriations. Any facility that would have been
740 issued a lower rate for the fiscal year ending June 30, 2014, or the fiscal
741 year ending June 30, 2015, due to interim rate status or agreement with
742 the department, shall be issued such lower rate. For the fiscal years
743 ending June 30, 2016, and June 30, 2017, rates shall not exceed those in
744 effect for the period ending June 30, 2015, except the rate paid to a
745 facility may be higher than the rate paid to the facility for the period
746 ending June 30, 2015, if a capital improvement approved by the
747 Department of Developmental Services, in consultation with the
748 Department of Social Services, for the health or safety of the residents
749 was made to the facility during the fiscal year ending June 30, 2016, or
750 June 30, 2017, to the extent such rate increases are within available
751 appropriations. For the fiscal years ending June 30, 2016, and June 30,
752 2017, and each succeeding fiscal year, any facility that would have been
753 issued a lower rate, due to interim rate status, a change in allowable fair
754 rent or agreement with the department, shall be issued such lower rate.
755 For the fiscal years ending June 30, 2018, and June 30, 2019, rates shall

756 not exceed those in effect for the period ending June 30, 2017, except the
757 rate paid to a facility may be higher than the rate paid to the facility for
758 the period ending June 30, 2017, if a capital improvement approved by
759 the Department of Developmental Services, in consultation with the
760 Department of Social Services, for the health or safety of the residents
761 was made to the facility during the fiscal year ending June 30, 2018, or
762 June 30, 2019, only to the extent such rate increases are within available
763 appropriations. For the fiscal years ending June 30, 2020, and June 30,
764 2021, rates shall not exceed those in effect for the fiscal year ending June
765 30, 2019, except the rate paid to a facility may be higher than the rate
766 paid to the facility for the fiscal year ending June 30, 2019, if a capital
767 improvement approved by the Department of Developmental Services,
768 in consultation with the Department of Social Services, for the health or
769 safety of the residents was made to the facility during the fiscal year
770 ending June 30, 2020, or June 30, 2021, only to the extent such rate
771 increases are within available appropriations. For the fiscal year ending
772 June 30, 2022, rates shall not exceed those in effect for the fiscal year
773 ending June 30, 2021, except the commissioner may, in the
774 commissioner's discretion and within available appropriations, provide
775 pro rata fair rent increases to facilities that have documented fair rent
776 additions placed in service in the cost report year ending September 30,
777 2020, that are not otherwise included in rates issued. For the fiscal year
778 ending June 30, 2023, rates shall not exceed those in effect for the fiscal
779 year ending June 30, 2022, except the commissioner may, in the
780 commissioner's discretion and within available appropriations, provide
781 pro rata fair rent increases to facilities which have documented fair rent
782 additions placed in service in the cost report year ending September 30,
783 2021, that are not otherwise included in rates issued. For the fiscal years
784 ending June 30, 2022, and June 30, 2023, a facility may receive a rate
785 increase for a capital improvement approved by the Department of
786 Developmental Services, in consultation with the Department of Social
787 Services, for the health or safety of the residents during the fiscal year
788 ending June 30, 2022, or June 30, 2023, only to the extent such rate
789 increases are within available appropriations. There shall be no increase
790 to rates based on inflation or any inflationary factor for the fiscal years

791 ending June 30, 2022, and June 30, 2023. Notwithstanding any other
792 provisions of this chapter, any subsequent increase to allowable
793 operating costs, excluding fair rent, shall be inflated by the gross
794 domestic product deflator when funding is specifically appropriated for
795 such purposes in the enacted budget. The rate of inflation shall be
796 computed by comparing the most recent rate year to the average of the
797 gross domestic product deflator for the previous four fiscal quarters
798 ending March thirty-first. Any increase to rates based on inflation shall
799 be applied prior to the application of any other budget adjustment
800 factors that may impact such rates. For the fiscal year ending June 30,
801 2024, the department shall determine facility rates based upon 2022 cost
802 report filings subject to the provisions of this section, adjusted to reflect
803 any rate increases provided after the cost report year ending June 30,
804 2022, and with the addition of a two per cent adjustment factor. No
805 facility shall receive a rate less than the rate in effect for the fiscal year
806 ending June 30, 2023. For the fiscal year ending June 30, 2024, the
807 minimum per diem, per bed rate shall remain at five hundred one
808 dollars for a residential facility licensed pursuant to section 17a-227 and
809 certified to participate in the Title XIX Medicaid program as an
810 intermediate care facility for individuals with intellectual disability.
811 There shall be no increase to rates based on any inflationary factor for
812 the fiscal year ending June 30, 2024. For the fiscal year ending June 30,
813 2024, and each subsequent fiscal year, the commissioner may, in the
814 commissioner's discretion and within available appropriations, provide
815 pro rata fair rent increases to facilities that have documented fair rent
816 additions placed in service in the cost report years that are not otherwise
817 included in rates issued. For the fiscal year ending June 30, 2025, the
818 department shall determine facility rates based upon 2023 cost report
819 filings subject to the provisions of this section, adjusted to reflect any
820 rate increases provided after the cost report ending June 30, 2023. A
821 facility may receive a rate that is less than the rate in effect for the fiscal
822 year ending June 30, 2024, but shall not receive a rate less than the
823 minimum per diem, per bed rate. For the fiscal year ending June 30,
824 2025, the minimum per diem, per bed rate shall remain at five hundred
825 one dollars for a residential facility licensed pursuant to section 17a-227

826 and certified to participate in the Title XIX Medicaid program as an
827 intermediate care facility for individuals with intellectual disability.
828 There shall be no increase to rates based on any inflationary factor for
829 the fiscal year ending June 30, 2025. For the fiscal year ending June 30,
830 2026, the department shall determine facility rates based upon 2024 cost
831 report filings subject to the provisions of this section, adjusted to reflect
832 any rate increases provided after the cost report ending June 30, 2024.
833 Additionally, the facility shall receive a rate that is three and four-tenths
834 per cent greater than the calculated rate, except that any facility that
835 would have been issued a lower rate effective July 1, 2025, due to interim
836 rate status, or agreement with the department, shall be issued such
837 lower rate effective July 1, 2025. For the fiscal year ending June 30, 2026,
838 there shall be no minimum per diem, per bed rate for a residential
839 facility licensed pursuant to section 17a-227 and certified to participate
840 in the Title XIX Medicaid program as an intermediate care facility for
841 individuals with intellectual disability. There shall be no increase to
842 rates based on any inflationary factor for the fiscal year ending June 30,
843 2026. For the fiscal year ending June 30, 2027, each facility shall receive
844 a rate that is five and eight-tenths per cent greater than the rate in effect
845 for the period ending June 30, 2026, except that any facility that would
846 have been issued a lower rate effective July 1, 2026, than the rate for the
847 period ending June 30, 2027, due to interim rate status, or agreement
848 with the department, shall be issued such lower rate effective July 1,
849 2026. For the fiscal year ending June 30, 2028, each facility shall receive
850 a rate that is six and three-tenths per cent greater than the rate in effect
851 for the period ending June 30, 2027, except that any facility that would
852 have been issued a lower rate effective July 1, 2027, than the rate for the
853 period ending June 30, 2027, due to interim rate status, or agreement
854 with the department, shall be issued such lower rate effective July 1,
855 2027. Effective January 1, 2028, each facility shall receive a rate that is six
856 and three-tenths per cent greater than the rate in effect for the period
857 ending December 31, 2027, except that any facility that would have been
858 issued a lower rate effective January 1, 2028, than the rate for the period
859 ending December 31, 2027, due to interim rate status, or agreement with
860 the department, shall be issued such lower rate effective January 1, 2028.

861 For the fiscal years ending June 30, 2024, and June 30, 2025, a facility
862 may receive a rate increase for a capital improvement approved by the
863 Department of Developmental Services, in consultation with the
864 Department of Social Services, for the health or safety of the residents
865 during the fiscal year ending June 30, 2024, or June 30, 2025, only to the
866 extent such rate increases are within available appropriations. For the
867 fiscal years ending June 30, 2026, and June 30, 2027, a facility may receive
868 a rate increase for a capital improvement approved by the Department
869 of Developmental Services, in consultation with the Department of
870 Social Services, for the health or safety of the residents during the fiscal
871 year ending June 30, 2026, or June 30, 2027, only to the extent such rate
872 increases are within available appropriations. Any facility that has a
873 significant decrease in land and building costs shall receive a reduced
874 rate to reflect such decrease in land and building costs. For the fiscal
875 years ending June 30, 2012, June 30, 2013, June 30, 2014, June 30, 2015,
876 June 30, 2016, June 30, 2017, June 30, 2018, June 30, 2019, June 30, 2020,
877 June 30, 2021, June 30, 2022, June 30, 2023, June 30, 2024, June 30, 2025,
878 June 30, 2026, and June 30, 2027, the Commissioner of Social Services
879 may provide fair rent increases to any facility that has undergone a
880 material change in circumstances related to fair rent and has an
881 approved certificate of need pursuant to section 17b-352, 17b-353, 17b-
882 354 or 17b-355. Notwithstanding the provisions of section 17-311-52 of
883 the regulations of Connecticut state agencies, when determining facility
884 rates for the fiscal year ending June 30, 2027, the department shall waive
885 the separate inflation cost limitation on direct care costs as reported in
886 the 2024 cost report filings. The waiving of this limitation shall be
887 applied prior to the application of any statutory rate increases. The
888 Department of Social Services shall amend the regulations of
889 Connecticut state agencies to allow for the waiver of the separate
890 inflation cost limitation on direct care costs when rebasing rates for
891 intermediate care facilities for individuals with intellectual disabilities
892 after the fiscal year ending June 30, 2027. Notwithstanding the
893 provisions of this section, the Commissioner of Social Services may,
894 within available appropriations, increase or decrease rates issued to
895 intermediate care facilities for individuals with intellectual disabilities

896 to reflect a reduction in available appropriations as provided in
897 subsection (a) of this section. For the fiscal years ending June 30, 2014,
898 and June 30, 2015, the commissioner shall not consider rebasing in

965 exemption applicable to such property, on the assessment list in such
966 municipality for the assessment date two years prior to the
967 commencement of the state fiscal year in which such grant is payable.

969 airport shall be paid to any municipality in which the airport is located,

986 for any exemption applicable to any college and hospital property under
987 the provisions of section 12-81, would have been paid with respect to
988 college and hospital property on the assessment list in such municipality
989 or fire district for the assessment date two years prior to the
990 commencement of the state fiscal year in which such grant is payable.

991 Sec. 27. Section 2-83 of the general statutes is repealed and the
