AN ACT CONCERNING ROAMING DOGS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Section 22-364 of the general statutes is repealed and the
2 following is substituted in lieu thereof (*Effective October 1, 2026*):

3 (a) No owner or keeper of any dog or livestock as defined in section
4 22-381 shall allow such dog or livestock to roam at large upon the land
5 of another and not under control of the owner or keeper or the agent of
6 the owner or keeper, nor allow such dog or livestock to roam at large on
7 any portion of any public highway and not attended or under control of
8 such owner or keeper or an agent of such owner or keeper, provided
9 [nothing in this subsection shall be construed to limit or prohibit the use
10 of hunting dogs during the open hunting or training season] this section
11 shall not apply to the use of a (1) hunting dog during the open hunting
12 or training season, (2) dog used in the handling and control of livestock,
13 or (3) dog engaged in a search or rescue operation. The unauthorized
14 presence of any dog or livestock on the land of any person other than
15 the owner or keeper of such dog or livestock or on any portion of a
16 public highway when such dog or livestock is not attended by or under
17 the control of such owner or keeper, shall be prima facie evidence of a
18 violation of the provisions of this subsection. [Violation of any provision
19 of this subsection shall be an infraction.] The animal control officer or

20 regional animal control officer appointed pursuant to section 22-328, 22-
21 331 or 22-331a, as applicable, of any city or town in which any such dog
22 or livestock is found roaming at large may, in addition to any other
23 remedies provided by law, seek an order enforcing the provisions of this
24 section, including an injunction, from the superior court of the judicial
25 district in which such dog or livestock is found roaming at large.

26 (b) A violation of subsection (a) of this section concerning livestock
27 shall be an infraction.

28 (c) (1) Any owner or keeper of any dog who violates subsection (a) of
29 this section shall be (A) fined (i) not more than three hundred fifty
30 dollars for a first violation, or (ii) not more than five hundred dollars for
31 a subsequent violation, or (B) guilty of a class C misdemeanor for a third
32 or subsequent violation that occurs during the one-year period
33 following the immediate prior violation.

34 [(b)] (2) Any owner or keeper of any dog who, knowing of the vicious
35 propensities of such dog and having violated [the provisions of]
36 subsection (a) of this section within the preceding year, intentionally or
37 recklessly violates [the provisions of] subsection (a) of this section shall
38 be fined not more than one thousand dollars or imprisoned not more
39 than six months, or both, if such dog, while roaming at large, causes
40 physical injury to another person and such other person was not teasing,
41 tormenting or abusing such dog.
