### ***OFA Fiscal Note***

#### ***Potential Revenue Gain***

The amendment strikes the underlying bill and its associated fiscal impact.

The amendment allows DPH to impose a maximum civil penalty of \$2,000 per violation on any hospital that fails to provide an annual attestation concerning private equity control and influence, resulting in a potential General Fund revenue gain beginning in FY 27. The exact revenue gain, if any, is dependent on the number of violations and agency's discretion regarding civil penalties.
