"AN ACT PROHIBITING CERTAIN LICENSEES AND REGISTRANTS FROM SELLING, DISPENSING, TRANSFERRING OR DELIVERING ANY DRUG OR DEVICE TO EXECUTE A COURT-IMPOSED SENTENCE OF DEATH."

1 Strike lines 162 to 165, inclusive, in their entirety and substitute the
2 following in lieu thereof:

3 "(10) Manufacturing, selling or dispensing any drug with actual
4 knowledge that the person purchasing or receiving such drug directly
5 from the applicant intends to use such drug to execute a sentence of
6 death imposed by a court; and"

7 Strike lines 180 to 183, inclusive, in their entirety and substitute the
8 following in lieu thereof:

9 "(5) Manufacturing, selling or dispensing any drug with actual
10 knowledge that the person purchasing or receiving such drug directly
11 from the registrant intends to use such drug to execute a sentence of
12 death imposed by a court; or"

13 Strike lines 186 to 194, inclusive, in their entirety and substitute the
14 following in lieu thereof:

15 "(e) The commissioner shall not issue or renew a certificate of
16 registration unless the applicant or registrant seeking such certificate or
17 renewal submits to the commissioner, in a form and manner prescribed
18 by the commissioner, a signed, written statement attesting that such
19 applicant or registrant shall not manufacture, sell or dispense any drug
20 with actual knowledge that the person purchasing or receiving such
21 drug directly from such applicant or registrant intends to use such drug
22 to execute a sentence of death imposed by a court."

23 Strike lines 381 to 384, inclusive, in their entirety and substitute the
24 following in lieu thereof:

25 "temporary permit or registration, has dispensed or distributed a
26 drug directly to another person with actual knowledge that such other
27 person intended to use such drug to execute a sentence of death
28 imposed by a court; (18) has falsified a continuing education"

29 Strike lines 408 to 410, inclusive, in their entirety and substitute the
30 following in lieu thereof:

31 "date of application, dispensed or distributed a drug directly to
32 another person with actual knowledge that such other person intended
33 to use the drug to execute a sentence of death imposed by a"

35 in lieu thereof:

36 "transfer a drug directly to another person with actual knowledge
37 that such other person intends to use the drug to"

38 Strike lines 455 to 457, inclusive, in their entirety and substitute the
39 following in lieu thereof:

40 "(4) Delivering a legend drug directly to another person with actual
41 knowledge that such other person intends to use the legend drug to

42 execute a sentence of death imposed by"
