My name is Debbie mair I live in Milford ct with my family in a house I purchase 30 years ago I'm Jamaican and black
Yale New Haven hospital s violently threatened to assaulted me with 7 heavy set staff who blocked emergency room door 9-Bed -9

Nurse Lisa McCarroll violently threatened me and forced me to sign a blank form on the computer pad After i signed she ordered a tech to draw 20 tubes of blood to check for 20 different types of drugs damaged my arm blocked the door refused to let me take a shower for 3 days— My Cigna insurance card was charged \$30,000 dollars. A false medical record was given to the Milford's police department by yale hospital gave them an emergency room request form state that I was a danger to my self and others was later amended by Yale New Haven hospital 20 York street New Haven ct The Milford Police Department Cheif Mello published this emergency room request form after it was amended to their attorney and the CHRO and to the residents of Milford's Connecticut who used it to violently gang stalk me used by Napaul who was arrested after he surveillance me followed me to Walgreens and violently assaulted me twice on 5/14/21. He was arrested and placed in a program but was dismissed after he completed the program for a year 71 Plainview street Starford ct

Melvin moral

Violently assaulted me
After his arrest on 8/23/21
His son Austin moral came to my house about 8-10 times sexually harassed me by video recording my butt while I do yard work
Violently coming to my house driving to by house every time I open my door or outside recording me from his car still stalking and harassing me racially
And after Melvin moral was arrested
His wife a yale New Haven hospital employee
Call me a mental illness monkey

After Yale New Haven gave the emergency room service form to the police department
The police officers Noss and Barbour gave it to a court judge at Milford court during a false arrest by these two police officers. Hired an attorney for the false arrest my case was set back because of COVID-19- during that time my attorney became a judge. So he send another attorney from his office to represent me her Name Malisa rose smith- I never met her however she call me and told me state attorney Matthew Kalthoff and STANGO who is now a judge in Danbury. Smith told me not to come to my court date trial hearing because. State attorney Mathew Kalthoff said the Milford's police department said I have mental illness and was committed by yale New Haven hospital and that state attorney Matthew Kalthoff and STANGO changed their mind about the arrest and now the police department wants me to bring a letter from my psychiatrist to place into my file because I'm mentally illness i told the attorney smith I will not bring a letter from a psychiatrist because I don't have a psychiatrist she said I have to I refuse and I was given a court date for 6/17/21. When I got there STANGO and Smith whose I never met said they will drop my criminal arrest if i give a a letter from a psychiatrist i refuse and told STANGO to remove smith from my case STANGO send me to the public defender office and told me to ask them for a different attorney, after waiting at the public defender

office for approximately 30 minutes STANGO came to the office told me only a judge can remove smith from my case and he gave me another court date for the false arrest by Noss and Barbour Milford police officers. At my court date 7/26/21. Attorney smith and State attorney (STANGO now a judge in Danbury). Blinded sided me in court— both lying to judge Dennis telling her they asked me for a letter from a psychiatrist from 2020. August 2020 (. And now it's July 2021 and I refuse and they handed the judge 4 police reports from Noss and Barbour the February 8 2020 body camera from the police department and the emergency room request form from Yale New Haven hospital where it was stated that I was committed. Both smith and STANGO told the judge that the police department told them I was incompetent and they both ordered the incompetent evaluation. The judge said the case was so old and I did not do what attorney smith asked me to do and what Matthew Kalthoff and STANGO asked me to do so she was going to grant their order for the competency evaluation. I went to the competency evaluation it was conducted by. The psychiatrist from Yale New Haven hospital inc. During the evaluation smith called the 3 Yale hospital psychiatrist and told them that (called her a racist liar) and attorney smith called them on 8/13/21 and 8/23/21. I was found incompetent on my court date 9/1/2021. State attorneys Matthew Kalthoff and STANGO wrote that there was an ambulance waiting outside to take me at 12 noon on 9/1/21 because they received 500 hundred letters from the Milford's residents that they no longer wanted me to live in their neighborhood and the Yale psychiatrist found me (incompetent). In the morning at 9 am I told smith I can't stay for 12 noon because I work 46 hours a week at Starbucks. Smith did. Not tell me I was going to be locked in a psychiatric mental hospital for dangerous prisoners. I found out in a letter she sent that there was a warrant for my failure to appear on 9/1/21 and that I should turn myself into the Milford police department. Hire another Attorney. Who told me not to turn myself in because I have a bond which was not told to me by attorney smith. I was false arrested again on 10/7/2021. I was told to sell and move by state attorney Mathew Kalthoff and STANGO. I moved to Florida when I received two orders for civil protection in my mail box in Florida from Milford court From Trease Nowlin 14 Robbie circle Milford ct 06460. And from Melvin moral granted by the Milford's court 14 west river street Milford ct 06460. For 11/5/21 to 4/23/23

Melvin moral said in his civil order that he did not want me to walk or drive in Milford Connecticut

While in Florida Matthew Kalthoff and STANGO

Told my attorney that I should come back to

Court

But not to my house

My attorney said i should find some where else to stay and wait for my court date on March 22,2022

Because states attorneys

STANGO and

Matthew Kalthoff said I'm not allowed to live in my home in Milford

My attorney said Matthew Kalthoff and STANGO said if I did not come to Court

There would be another
Warrant for a third arrest

I went to court with my new attorney
Jill
Who told me STANGO and
Matthew Kalthoff
Place me on probation for 13 months in
A competency program and i still have an arrest
For 13 months

If i violated i will be locked in
A mental hospital for dangerous prisoners

Because i was found incompetent

I was never told the incompetent was dismissed
