

To Whom This Concerns:

I'm writing this about the unjust things I have witness while in Doc.

Most in the last year in Osborn C.I. I hope my name can be left off because I know I will be retaliated against, as I have seen others and been warped. I'll be shaken down with everything I have destroyed, given an unjust ticket or moved cell blocks over and over. But someone needs to speak up about this treatment.

First two officers (Spence and Lee). After getting into arguments with inmates yell out on the block that they are pedophiles trying to get other inmates to harass them in both cases they (inmates) don't have any sexual assault charges. In case of Spence he told an inmate to "suck his Dick" causing a back and forth argument.

Then the CO responded since your white you must be here for beating up women or touching kids. Then yell out his

cell number is a pedophile. Now everyone is in fear of being next. BOTH CO's use racist remarks to rile up the inmates.

CO Spence tried to get other black inmates to do something asking if they let that go. A \$400 hit was put on him. But nothing happened.

I know inmate Bret was made "Bret was a inside worker in H-block who was moved to D Block for this. Multiple grievances about CO Spence, and she was fired from his job and moved even though this all happened at his cell. The CO's always punish us for the actions of one inmate's actions. They always try getting other inmates to solve the problems with the CO's. Saying no rec or commissary because of cell #, say inmates to handle it, the CO's say police your own. How with force?

Then they started saying work and visits count as our Rec time. I can't call love ones, workout exercise or shower while at work, and most inmates don't get visits so some jobs get 2 hours of Rec a day as a level 2 or 3. Unit Supervisor Casey told us "Tough it up or quit."

But a bad work report can cause inmates to be moved, lose good time and possible ~~to~~ parole being denied. So now we have to choose exercise, work or talk to loved ones or parole as it is on our O.A.P. IF you disrupt a CO's sleep or cell phone usage, especially when short staffed, ^{or watching FOOTBALL} they lockdown or prepare for cell to be tossed or be humiliated if not a ticket for something, they all have phones and watches.

When Brass tours will ask questions and tell us one thing, But Tell the officers another purposely causing major conflict. Inmates goes by what being told, Officers not believing Inmate, as they should follow the rules the officer stated.

I personally asked supervisor Casey to write in the book what she told me to not have any problems. She told me to wait, deal with it, and do I like it here man up. and officers telling me IF you don't like it do what you got to do. Casey is know for humiliating people about their manliness, about their manhood and is know to be there at our ~~strip~~ ^{Strip} searches, she has caused us to go to segregation

I know inmates who grieved or felt humiliated and shamed by this. People have complained but because of her rank they tell us she can be there. Then the inmate is sent to a different jail

On topic of Humiliation and private matters, some CO's like to look at ^{our mail} pictures in the block before they hand them out or read our KOP med's and make comments, like "stop acting tough or your Herpes will show" or "your blood pressure will go up and stroke out"

Next I would like to talk about CO's refusal to call Brass when inmate makes a request when they are breaking the rules, being unfair, or dealing with problems they don't know fully, like mental health issues. If inmates try to resolve issues civilly, the CO's lock you up and when asking to speak to Brass or LT. because the CO is wrong they will refuse

only when multiple inmates refuse to be locked up or start getting aggressive to request Brass. By then most Brass just threaten mass or write riot tickets. If inmates say something the next day they say to call them (Brass) if it happens again, but same problem they don't call

They seem to want us unruly, hostile or to Riot, but to them doing it the proper way is wrong. Even after lockup and asking for Brass, they laugh and say don't come to jail. One time this happen because officers watching movie on a phone, and they were interrupted so they locked up only our block, and we lost rec the next day. The Captain said for us to have CC's call, But how? unless inmates become aggressive, Refuse orders or Refuse to be locked up we go to seg for asking.

Another Issue is Food, They are so strict on us taking food, But officers get 3, 4, 5 Burgers and chicken, IT ADDS UP LESS FOOD FOR INMATES, sometimes inmates wouldn't get any food or meal of Burgers, chicken, eggs, Pizza because they run out, But officers take multiple helpings, sometimes double up on each serving

There was a major issue with eggs, inmates were screamed at, called thieves, and refused 2nd helpings because a lot of eggs went missing. But don't include the multiple helpings officers take
 Two officers come that morning and took ~~two~~ ^{one} cases of eggs that's 120 eggs, screaming at a inmate for stealing

he ~~was~~ mention THE 120 eggs was fired from his job and FOR Stealing 2 sugar packets single serve size, that were in his pocket

We are Never to speak about OFFICERS Taking our FOOD, KITCHEN WORK 101

Lastly I want to TALK about PROGRAMS THEY ARE SO FAR behind. BUT THEY TELL us we are on THE LIST, so STOP WRITING, THEY even say we are harassing or BOTHERING them FOR WRITING and asking progress every month TO GET INTO PROGRAMS. Programs we need to meet PAROLE THEM parole say WHY DIDNT complete or WHY NOT GETTING in, we should have done MORE to GET INTO THE PROGRAM. How? THE Counselors tell us parole won't hold it against us for NOT getting in. But at hearings they STATE to come back in a year or 18 months when you complete the program. a real catch 22 so they DO hold it against us.

I was sent Back to Finish a Program I was given 18 months to Finish a 6 week program that was delayed 3 times Before my hearing I was only able to get into THE PROGRAM Because parole ORDER IT. March 2025 told to come Back in 18 months, Finished The program May 2025 But must WAIT till June 2026.

Some programs will only take you if parole orders it. until you finish the videos. It is not right that I do everything right as asked and can not get into programs until denied by parole. They add more time because some programs just stop for 6 months or longer, because no one can run it.

Most inmates denied programs are just punished cause it's slow going and can't get it done.

mean while I'll be forced to do the same program as soon as I get home on parole or probation making it no matter if I did the same program on my own on bail and completed.

I'm mailing this through a 3rd party otherwise letters like this always get returned and open when they come back in, even disappear then I would be waiting for retaliation should it happen. I never got a ticket here and only 2 in 2 different times, but I'm sure for speaking up my life will become harder. There is way more but these are most recent I dealt with
