My name is Carroll Bumgarner-Ramos and this is the truth and nothing but the truth. I am a P.C. inmate, meaning I am in Protective Custody. I have been fighting for my innocence for going on thirteen years. I was held responsible for the death of a child and that is why I have been held in Protective Custody. Like I said I have been fighting for my innocence and with my first appeal I got a reversal on a Double Jeopardy claim making the reversal a case law and in the law library where all inmates can see the nature and details of my case. My case is Hi-Profile and all over Google and I have many issues with gang members due to my case and its connections. These are the reasons I'm being held in P.C. and I have been safe and secured since my sentencing. Recently within the last two years I have been going through a process where the staff that controls the P.C. unit is trying to remove my P.C. status putting me and my family at risk.

This is a type of targeting because there are many inmates that fill out there P.C. removal package and it does not make it past the Unit Managers office, and there cases are not as Hi-profile as mine. With a case such as mine there is no way I would be safe in General Population and the staff knows this and they also know that a case like mine definitely fits the criteria for a P.C. status and should never make its way to the Population Management office where Mr. David Snyder who has the last say in my P.C. status review, and who probably is really tired of doing this paper work, like every five months. This is a type of mental torture and puts stress levels through the roof and very taxing on my ageing marvelous Mother who does not deserve to worry if her son is going to be hurt or set up by inmates or the staff who swore to protect her son. Remind you that now that inmates have tablets it is a lot easier for inmates to get access to why people are in jail for, so there is no hiding or lying about why a person is in jail for. The truth will always come

out through Google or the media. So a person like me would never be safe in General Population. I bring this to your attention hoping that P.C. inmates, me included can some how get help with this and some how someone can put a stop to the process of trying to throw P.C. inmates to the wolves, meaning the inmates in General Population. Also, I write this letter at my own risk, because me writing this can easily make me a target, for I have seen in the past, inmates become targets for less.

Again, everything written in this letter is the truth and nothing but the truth. Oh, and I forgot, on top of everything else I also have Multiple Sclerosis and these stresses can easily cause me to have a m.s. relapse. Now on the medical part of this letter, the D.O.C medical staff and the Uconn medical staff have really bad communication between each other and I say this because, every year due to my M.S. I have to take eight UCONN trips due to all my appointments, and the staff at Uconn stated in my medical file and reports

it says and has been stated many times if not in every report that I should be housed in a single cell, meaning no cellmate because I have a compromised immune system and with the covid's and flu's I'm at risk.

This has been in Uconn's notes since 2022 when I was diagnosed on May 22nd. This is another issue I have been dealing with. I would like to say thank you for your time and it's good to know that someone is willing to listen, even if it is just a P.C. inmate...
