MY NAME IS KEVIN P. CAMPBELL #360498.

I AM SERVING A 40 YEAR SENTENCE FOR MURDER.

HOW I WAS FOUND GUILTY OF SUCH IS A MATTER STILL BEING LITIGATED.

MY PURPOSE HERE TODAY IS TO SHED LIGHT ON THE SUBJECT OF THE NEED FOR THE RESUMPTION OF THE LAW LIBRARY ON OUR TABLETS, AND WHY THE D.O.C. IS NOT THE BEST CHOICE FOR DETERMINATION OF ITS CONTENT.

TO BEGIN: HAVING PROPER LAW RESOURCES IS CRITICALLY IMPORTANT AND IS REQUIRED BY LAW.

WHEN I WAS IN HIGH BOND AT WALKER C.I. (4 YEARS) THERE WAS NO LAW LIBRARY TO ACCESS.

OVER THE YEARS I HAVE ACCRUED MUCH, AND QUITE IRONICALLY I NOW HAVE MORE CURRENTLY RELATIVE CASE LAW THAN THE LIBRARY AT MACDOUGALL C. I. IN MY CELL.

A BIG SOURCE OF INFORMATION FOR MY SEARCH OF LEGAL CASES AND ISSUES IS MY DAILY NEWS-PAPER THAT MY FAMILY SUPPLIES TO ME.

I KEEP AN EYE OUT FOR ANY EXONERATIONS, AND FEDERAL SUPREME , CIRCUIT, APPELLATE COURTS, STATE SUPREME, APPELLATE, AND HABEAS COURT DECISIONS. ALSO NEWS WORTHY ARTICLES INVOLVING LAWS.

ONE SUCH ARTICLE CAUGHT MY ATTENTION.

IT REFERENCED " THE CONNECTICUT PROSECUTION STANDARDS, BY THE CT. DIVISION OF CRIMINAL JUSTICE, 207 PAGES, FIRST EDITION, MAY 2026".. (C.P.S.).

MY CURRENT APPEAL INVOLVES A DECEITFULLY TRIAL PROSECUTOR (PROSECUTORIAL MISCONDUCT) AND PERJURY BY POLICE.

MY FAMILY LOCATED THE C.P. S. ON LINE, MADE COPY FOR ME AND MAILED IT TO THE PRISON.

IT IS IMPORTANT TO NOTE THAT THE C.P.S. CAME OUT IN THE WAKE OF THE " HENRY LEE" FALSE TESTIMONY THAT LEAD TO THE CONVICTIONS OF RICK BIRCH AND SHAWN HENNING AT A COST TO THE STATE AND TOWN OF NEW MILFORD OF OVER \$30 MILLION. (SEE: U.S.D.C. CASE# 3:20 CV. 01790).

ANOTHER NOTE OF INTEREST FOR ME IS THE PROSECUTOR IN THAT CASE (BIRCH and HENNING) IS THE SAME ONE IN MY WRONGFUL CONVICTION.

ONE CAN EASILY SEE WHY SUCH A THING LIKE THE C.P.S. MAY ASSIST ME!

WHEN IT ARRIVED AT THE PRISON THE HEAD LIEUTENANT OF INTELLIGENCE INFORMED ME IN WRITING THAT THE C.P.S. IS FORBIDDEN AND WAS NOT TO BE DELIVERED.

I TRIED THE ADMINISTRATION REMEDY'S TO NO AVAIL!

THEN IT (C.P.S.) WAS (THEY SAY) RETURNED TO SENDER.

I CONTACTED MY LEGAL REPRESENTATIVE AND FOUND THAT THERE IS NO LEGITIMATE

REASON FOR IT'S REJECTION.

MY FAMILY FORWARDED A COPY TO THEM AND THEY QUICKLY SENT IT TO ME BY LEGAL MAIL.

AGAIN; NO WHERE IN IT'S CONTENT (C.P.S.) IS THERE ANY WARNINGS OR DESCRIPTIONS OF IT BEING TOP SECRET, CLASSIFIED, OR NOT PUBLIC.

THIS STORY IS TRUE!

THE FIRST CHANCE I HAD, I WENT TO THE PRISON LIBRARY AND MADE A COPY FOR USE BY ALL.

THIS STORY CLEARLY ILLUMINATES THE NEED FOR SOMEONE OTHER THAN D.O.C. TO SEE THAT THE LAW REQUIRING LEGAL LAW LIBRARY RESOURCES IS FULFILLED TO IT'S FULLEST.
