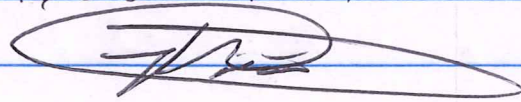


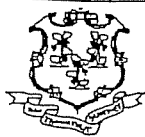

Request: This Complaint is about an Incident at OSBORN Correctional Institution in Somers, CT

Hereafter is all Upon Reasonable Information and Belief: In October of 2025, I Sent Del. Warden Donald Davis a letter from my attorney by accident. That letter contained information about a assault I suffered from DOC staff at Moodysall-Walker CI on April 4, 2025. Being aware of my future litigation against DOC employees, I feel I was Targeted by Staff. Lt. Gredy was a main co that harassed me. I was coerced, intimidated and Threatened by future use of force by officers, If I didn't sign my Ticket and Plead guilty. I received 3 intoxication Tickets and Assault on DOC employee Tickets at OSBORN. On 12-18-25, in F-BLOCK stairwell, I was Assaulted, and Punched Unconscious in a blind spot off camera. I was Charged at OSBORN with Assault on DOC. While I was at The hospital on 12-18-25, State Police

~~Continued~~ Took Pictures of my Injuries To My Head. I was also Thrown in (RTHU) Restrictive Housing Unit for 17 Days, with No Phone Call. On 12-19-25, when I was getting Wheelchaired To AIP from Mr. Lt. Gredy Threatened me and said "If I Come back To OSBORN He will Make sure I Leave in a Body Bag." This was all Unprofessional and Degrating. Upon information and Belief, There is No Video of This

Not because There was any Physical Evidence of Assault on DOC Employee. I was Threatened and Coerced into Signing My Ticket or suffer extra Sanctions at My hearing, early Next Morning in RTHU at OSBORN on 12-19-25, in The dark at 6am. I appealed that Decision and got Denied. I would Now like To Press Charges on said officers who Assaulted me for No Penological reason because I didn't Receive a Ticket for Disobeying a Direct order, or Interfering With Safety and or Security. No officer was hurt or hospitalized in This Incident. I would like Those officers Involved, who Assaulted Me Until I was Unconscious To Be

## Complain of Assault / Harassment / Discrimination Complaint : on (3-1-26)

This is a Complaint of Assault, Harassment and Discrimination through Intimidation through Gory, obstruction of Justice and Major misconduct Done By Department of Connecticut, (DOC) Department of Correctional Employees on March 1<sup>st</sup>, 2026 at Corigan Correctional Center. I was beat up, Assaulted, Thrown to the ground, Tackled, and or Punched in my face, while I resisting laying on my stomach. I was having a mental health Crisis and while holding my cane, I was pepper sprayed and thrown in RHU for 18 days for no Penological Reason.. with No Phone Call. This was against The Law Pursuant: Public Act NO. 22-18. Gen. Bill NO 459.. During my time in RHU Between 3-1-26 - 3-18-26, I lost 18 Pounds in 18 days.. Meaning the food given to me was below National Standards. I started PTSD started Kicking in because Prior Assaults by DOC employees. This was clear retaliation from officers because Past, Prior Grievances I wrote on officers at CCC.. back in 2024... I was never supposed to be sent back to Corigan Correctional Center for safety Reasons... During this Assault, I was jumped on by multiple officers. At this moment, I'm Physically Disabled while Holding a cane. Therefore, what kind of threat would justify me being, Assaulted, Punched in The Face and or Kicked.. The state police came and took pictures of my Black eye that I suffered. No officer was injured during this incident. This conduct was inhumane, cruel and unusual. Then on 3-10-26, Warden gave Lt. Pierson or Pierson, ~~then~~ a Direct order to allow me a Phone Call. Mr. Pierson ignored him and disregarded his order and didn't allow me a call. when other inmates got on the Phone.. This was clear discrimination and retaliation because I'm LGBTQ, and because I wrote him up in 2024 for threatening, Intimidation and Harassment.. I got charged by State Police with Assault on DOC employee. I was found guilty at a DHO on 3-10-26 which I appealed and got Denied.. I have suffered severe bodily harm, Mental & emotional Distress Due The continual Assaults.. I don't feel safe in DOC and I'm requesting compensatory, Punative Damages, Immediate Release for my Recovery and officers involved in any Assault on my behalf to be Fired, and or retrained.. due to The continual Disregard of my Medical Need, and DOC employees, I'm now in a wheelchair, Have continual Nightmares, Take Medication for Pain and calcium inflammation.. I currently have 2 claim-counter with CHRO and will be filing 2 more.

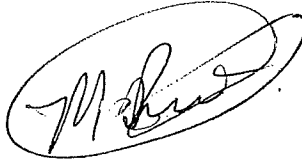

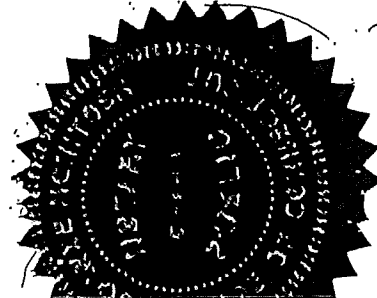
