look at my situation for instance I was adjudicate by doc, was found not guilty but an officer still managed to press charges even when I was found not guilty by there employment !!! now I'm going to court and I need legal assistance and a legal app was on the tablet but removed a week later bcuz other inmates didn't want other inmates to know what they were in prison for as if the information is not already public information so now let's say I did find a lawyer and I would like to reach out to them oh wait I can't bcuz we never have a counselor or a unit manager or you write and your requests are never answered until they get tired of hearing you complain then they tell you stop crying or get over it you be OK so then you find other means by having someone else reach out to someone for you to help and now they want to do there job when is time to take you to seg but never when is as simple as helping the inmate reach out to the kitchen to fix a diet tray or anything that'll assist the inmate we can never get any kind of help in this place bcuz no one wants to do there jobs and then they complain about more pay bcuz the inmates are violent but that's bcuz that's how they want it to be bcuz if nothing is going on then they have nothing to do but there job is not must about not being feed right or rec is a bigger problem here that needs to be address inmates or prisoners or however they want to look at us still have human rights the constitution we did a crime yes and doc job is not only to correct that but they don't how an you claim to your holding up your own mission statement but you want inmates to commit crimes by fighting each other whenever they want to move out of there cells bcuz there's a problem the cells are not ment to house too people not big enough
