

^{*} Other exemption criteria include age (not 19-64) and Medicare participation. Other exclusion criteria for future consideration include drug/alcohol treatment center, recent release from incarceration, Tribe members, veteran with rated disability, and parent/caretaker of individual with disability. Temporary Family Assistance (TFA), which also administers work requirements, is not expected to impact HUSKY D because TFA requires having child dependents (i.e., HUSKY A).




